### A/C REPLACEMENT SPECIFICATIONS FOR VILLA BELMONT CONDOMINIUM BUILDINGS 72, 76, 80, and 84

1. EQUIPMENT:

Brand: National Comfort Products, "Through-the-wall" type condensing units

Models: NCPC-018-3010 (1.5 ton)

NCPC-024-3010 (2.0 ton)

Dimensions: w=23-3/4" h=32" d=18-1/2"

#### 2. INSTALLATION:

- a. Vertical dimension in wall must be increased by removing existing wall sleeve and one row of brick from bottom of opening. Do not remove brick from top of opening.
- b. Will need to build up bottom of opening with cement so unit can be centered in wall opening with even spacing around all four sides. (approx. ½' gap). Use quick-setting cement like "Quikrete" to buildup and level bottom of opening.
- c. Unit should slightly pitch to the exterior and protrude from wall just enough to allow drainage holes at bottom-front of unit to clear wall. (approx. 1/4")
- d. Seal gap around unit from rear with spray foam. Seal gap around front of unit with DAP Exterior Latex Caulk. Trowel caulk to smooth finish.
  - e. DO NOT use metal or wood materials to seal exterior gaps around unit.
- f. Fasten new unit to wall using metal brackets and masonry wall anchors from inside of equipment room.
- g. Use Sherwin Williams "Villa Belmont White" for exterior painting. Painting is the sole responsibility of the unit owner.
